## MEMBERSHIP CRITERIA

1. Membership shall be open to all individuals regardless of sex, race, age, language or country of national origin.
2. Membership shall be open to Buddhist, Christian, Jewish, Hindu, Native American Indian, Muslim, and Taoist faiths. The Primary criteria shall be that the applicant actively pursue an absolute faith and belief in God. Ethical instruction as well as Kuden (secret oral instruction) shall be primarily in Christian terms according to the Holy Bible, as per the founding fathers of Danzan Ryu. Satanists and atheists are not welcome.
3. Members shall agree to treat one another according to the 'Golden Rule': to do unto others as you would have them do unto you. Members shall agree to the following precepts of Bushido (The Way of the Warrior):
  - A. *Loyalty: be loyal to God, country, parents/spouse, teachers, dojo and the Christian Jujitsu Association.*
  - B. *Honor: maintain a good name and a good reputation; do what you say and say what you do; maintain self respect.*
  - C. *Virtue: demonstrate valor; be deserving of merit, and demonstrate moral conduct.*
  - D. *Rectitude: demonstrate moral integrity and judgement.*
  - E. *Fearlessness: act upon your judgement with courage.*
  - F. *Righteousness: know your duty and act accordingly.*
  - G. *Justice: be fair in dealings with others.*
  - H. *Benevolence: be charitable and caring.*
  - I. *Politeness: observe the cultural amenities.*
  - J. *Veracity: be honest in word and action - be true to yourself and others.*
  - K. *Sincerity: be yourself and avoid 'putting on airs'.*
4. Members shall agree to support and defend the constitution of the United States of America.
5. Members will support and respect the sanctity of the family unit.
6. Members shall agree to maintain a daily spiritual practice of prayer and meditation in line with the Christian concept of 'loving God with all your heart, mind and soul'.
7. Members of the Christian Jujitsu Association may also hold memberships in other martial arts organizations, so long as the membership in other groups does not require a violation of the moral, ethical, and philosophical standards of the CJA.
8. Memberships may be terminated at any time without cause or prejudice by action of membership committee. The committee's action is final. The current membership fee shall be returned on termination of membership.
